**RULES FOR THE CONDUCT OF CANDIATES IN
THE EXAMINATION HALL**

Candidate should strictly observe these Rules

(Prepared by Examination Committee and approved by the Council)

Dated 5-6-62

1. Before entering the examination hall the candidate must leave outside all books, notes or papers he may have with him, and may take with him into the hall only his Admit Card, pen and penholder, and the instruments mentioned in Rule 10.
2. A candidate is permitted to enter the examination hall five minutes before the examination is due to commence. But will not receive the question paper until the time fixed for the commencement of the examination. No candidate will be admitted to the examination hall who is more than half an hour late.
3. A candidate is required to write his Studentship Number/ Studentship Application Reference Number, Roll Number, the subject, and the date of the examination in the spaces provided for these purposes on the cover of the main answer-book and the supplementary answer –books, if the details are not correctly filled in, the answer-book will be rejected.
4. The name of the candidate must not appear anywhere in the answer-book.
5. The answer should be numbered so as to correspond with the number of the question and if any question is divided into parts should also be numbered.
6. If more than one answer –book is required, a candidate will be supplied with an additional answer –book called the supplementary answer –book. In such a case, the main answer –book should be numbered serially as ‘2’, ‘3’ etc.
7. The hand-writing should be distinct and legible. Marks will be deducted if the answers are not easily readable. No credit will be given merely for writing lengthy answers.
8. No page should be torn off or otherwise detached from the answers book.
9. Nothing should be written on the question paper or blotting paper.
10. Mathematical tables, when permitted to use by the candidate, will be supplied by the Officer-in-Charge, but the candidate must bring his own drawing instruments and slide-rules.
11. Candidates must not speak during the examination except to the invigilator whose attention or attempting to obtain unfair assistance or using unfair means is liable to be expelled from the examination hall. The –Institution reserves the right to take any action in such cases as may be deemed proper.
12. No candidate will be permitted to leave the examination hall without finally giving up his answer-book until an hour has elapsed from the time of commencement of the examination. In case of urgent necessity, a candidate may, with the special permission of the invigilator temporarily leave the examination hall, but during such time he will be under the surveillance of a person deputed by the usual invigilator for that purpose.
13. They may be given the usual warning when the time for closing the examination approaches. The examination will be closed precisely on time and no grace time will be allowed.
14. Question should not be copied from the question papers on the answer-book before they are answered. Only the question number need be entered on the margin of the page of the answer-book.
15. The instructions printed on the both sides of cover page of answer-book should be read carefully and must be obeyed.
16. Candidates should write the answers in English and English only. Question answered in any other language shall not be examined.
